

AGENDA 6: Decision relating to manpower engagement through 7 nos. of agencies by the Board during the last couple of years.

C.E.O WBKVIB mentioned, there are 577 sanctioned posts under WBKVIB. At present only 51 regular employees are working. Out of these 5 to 6 employees will retire in the year 2024. So a huge staff shortage will arise and it will be difficult to run day to day work and also difficult to implement different developmental schemes. In this regard during the last couple of years 236 nos. of manpower were engaged through 7 nos. of agencies. The payments of this manpower are being given from

Head- 2851-00-105-002-36-00-V-01.

The Board advised C.E.O WBKVIB to minimize the agency (within two to three) and prepared a final list of manpower for better appreciation.

The Board approved the engagement of manpower and continues to pay wedges from Head-2851-00-105-002-36-00-V-01. Until further development/order from the Department. In this regardsthe Board decided to prepare to send a letter to the department for approval of manpower (236 no.s) in different categories to run day to day work of WBKVIB smoothly. The Board also recommended to send a letter for direct payment to the manpower/ contractual employees if Higher Authority approved to make payment from the appropriate head.

The Board also proposed to approach MSME&T Department for appropriate Head creation for disbursement of wages to the contractual employees.

<u>AGENDA 7:</u> Engagement of Contractual Manpower 'Technical and Non-Technical' for day to day work and improvement of Khadi and V.I activities.

C.E.O, WBKVIB proposed to initiate engagement of 3 nos. Contractual, Technical and Non-Technical personnel for day to day work for WBKVIB in an urgent basis, out of which 2 from

Textile Engineering (B. Tech) with at least 3 years' work experience and 1 from an MBA from any reputed recognized institutions in marketing. The proposed remuneration will be as per finance department norms. The payment may be made from the other grant/ Contingency fund / own fund.

The Board approved and considered the matter. Now it will be sent to the higher authority/Finance Department for approval.

AGENDA 8: Claim of MMDA for the year 2018-19. Present Position, Action taken etc.

The CEO, KVIB explained the status of MMDA already distributed for the FY 2017-18 and also stated the status of MMDA claimed for the FY 2018-19 amounting to Rs.227663129.00/-. The house perused the matter and the Special Secretary, MSMET requested to submit a copy of guideline of MMDA for better appreciation of the proposal. It is also noted that huge amount of MDA/MMDA fund have been diverted to the different schemes, contingency purpose, renovation purpose and miscellaneous expenditure. The Board observed the matter and discussed. A special audit may be made for these issues to find out the actual status of MDA/MMDA fund. The societies/ artisans are claiming their outstanding MMDA fund as they have given discount of their products for getting MMDA/MDA fund.

The Board perused the matter.

The budgetary allocation of the Board listed Khadi Institutions (KIs) along with the SFC approval by the KVIC and the matter of issuance of ISEC to the KIs has been described by the CEO, WBKVIB. The Board perused the matter.

AGENDA 10: Approval for revised 29 Tenants rent at different spaces (occupied by tenants) at Hemanta Basu Bhawan by WBKVIB which were calculated by 1st Land Acquisition Collector, Kolkata. Vide Memo No. 658-L.A. dated 29.09.2023.

The Board approved the proposal and decided to implement from 1st January, 2023 as new rent assessed by 1st Land Acquisition Collector, Kolkata.

AGENDA 11: Report on Audit and Accounts:-

Annual accounts of the WBKVIB for the Financial Year 2022-23 have been prepared and found profit amounting to Rs. 1,01,90,948.04/- submitted by our Chartered Accountant Farm M/S Mitra Ray and Dutta. The Board considered the matter and approved.

The Chairman requested to conduct a joint enquiry. Special Secretary of MSME&T Department suggested that list of projects where fund diversion took place need to be recorded. The Board perused the matter.

AGENDA 12: Status reports on Board's Direct Weaving & Spinning Production centre up to December-2023.

The Convenor of the house explained the status of Board's own production centers where production works had been postponed due to paucity of fund. The Board perused the matter with a suggestion to generate some surplus out of the sale- proceed. The Board also advised to keep the outlets of KVIB open from 12:00 Noon to 8:00 pm on working days.

The Board perused the report. Auction at Udaynarayanpur, Gaza, Ashoknagar etc. are under process. The Chairman opine Khadi Board will extend its production unit and Sales outlet to the semi- urban area through out West Bengal specially at backward regions. In this context Board will request MSME&T Dept. to allot specific fund for this purpose. The Board opined that Khadi Board is working for the benefit of poor and rural artisans and WBKVIB and KVIC Societies. So marketing and production is an important part of supply chain. The Board expressed that 'Janota Khadi' can be helpful for the all categories of economically backward or middle class people. The Board again opined that Khadi Board will manufacture and market for people of all ages. Khadi Board perused the matter and considered.

AGENDA 13: Status report of Muslin Tirtha under WBKVIB. Total sanctioned amount are Rs.81,60,000/- (Eighty-one Lakh sixty thousand rupees) only. Fund received 50% of the sanctioned amount.

Four proposals had been sent to the Depatment seeking working fund for four (4) Nos. of Muslin Tirthas.

A provision of 'Recurring Fund' was sought for in the DPR.

The CEO, KVIB acknowledged the receipt of working fund for Muslin Tirthas and the Board perused the matter. Accordingly, the fund has been sub- allotted to the concern district to start the Muslin Tirthas within January, 2024. A guideline has been prepared to make expenditure for this purpose. The Board considered the matter and approved.

AGENDA 17: Handover of Kalyani Gramin Showroom from agency to District Officer, Nadia.

Kalyani Gramin Showroom was running with the supervision of R. K. Associates. Now the gramin is closed. The Board proposed to taken over the charges of Kalyani Gramin under WBKVIB. Accordingly the process has been started. The Board considered the matter and advised CEO, WBKVIB to taken over the charges of Kalyani Gramin as soon as possible.

AGENDA 18: Outstanding Bills on Annual Maintenance for WBKVIB assets.

The Board perused the report. The Board decided to claim the pending bills to the Dept. for post facto- approval and after receiving the amount the bills will be paid to the agencies.

AGENDA 19: Approval for pay structure is fixed equally on the basis of joining date of Contractual Staffs who were engaged through different agencies.

AGENDA 20: Approval for Gratuity Enhancement from 8 lakh to 12 lakh on retirement benefit.
