



# INVITATION FOR ENROLMENT OF BUYERS FOR PARTICIPATION IN ELECTRONIC BIDDING FOR SALE OF KHADI MATERIALS OR PRODUCTS FROM DIFFERENT KHADI PRODUCTION UNITS UNDER WBKVIB FROM ALL OVER WEST BENGAL

## 1. INTRODUCTION

West Bengal Khadi and Village Industries Board (here in after referred to as “WBKVIB” or “Seller”) has decided to sell various grades of Khadi material and products from different khadi production units under WBKVIB from all over West Bengal. Tentative cumulative quantity shall be lot wise.

The stock as per details in Annexure1 (here in after referred to as “Stocks”), will be offered for sale through a competitive electronic bidding process (e-auction). The Seller represents and warrants that it is the rightful and legal owner of the Stocks and possesses clear and marketable title for auctioning, selling and disposing of the Stocks. The Stocks are free and clear of all encumbrances. For this purpose, Seller will be utilizing the services of NCDEX e Markets Limited (NeML) to offer Stocks for sale through their online platform. Interested participants may visit [www.market.neml.in](http://www.market.neml.in) to know the details of stocks for e-auction(s).

The Seller will declare the grade and description of the material, same shall be incorporated in the Annexure1.

For participating in the sale of stock, registration with NeML is mandatory. Applications are invited from eligible participants for enrolling as buyers of Fabric. The terms and conditions mentioned in this tender document will be binding on the bidders who deposit EMD and participate in the e-auction. The interested buyers/bidders who wish to participate must read the terms and conditions thoroughly before participation in the on-line auction. Any amendment in the terms and conditions of this ‘Khadi and village industries board’ Tender will be intimated by issuing circular on the website of NCDEX e Markets Ltd at [www.market.neml.in](http://www.market.neml.in) and shall be binding on the bidders. Applicants are requested to visit the website on a regular basis. The procedure for enrolment and registration of buyers, terms and conditions of purchase of stocks are detailed below.

## 2. DOCUMENTS TO BE FURNISHED TO NCDEX e MARKETS LIMITED (NeML) ALONG WITH APPLICATION FOR REGISTRATION

Interested bidders need to get registered online with NCDEX e Markets Limited, URL for registration shall be [market.neml.in](http://market.neml.in). Post registration approval interested bidders must submit below mentioned documents for getting allocation of market segment.

- a) Copy of the self-attested PAN card
- b) Certificate of registration under GST as applicable.

- c) Duly signed copy of this 'West Bengal Khadi and village industries' Tender having accepted all the terms and conditions contained therein.
- d) Electronic fund transfers to NCDEX e Markets Ltd, for Rs.1000/- (Rupees One Thousand only) + Applicable GST (Presently @18%) (Total Rs.1180/-) to be made during online registration as registration fees.

The interested applicants may visit website [www.market.neml.in](http://www.market.neml.in) for any relevant information and application form for registration with relevant Annexure to be downloaded from the website of NCDEX e Markets Ltd [www.market.neml.in](http://www.market.neml.in). Requests for forwarding application form through post/ couriers will not be entertained. Regarding enrolment as participant on NCDEX e Markets Ltd., interested participants can also contact the Customer Service Group on phone number (022)66473153/54 or Mr. Arindam Sanyal (Mob: 9836006022). Those who have already registered as Commodity Participants/ Registered Participant on NCDEX e Markets Ltd and who have renewed their Registered Participant membership for the current financial year need not separately register. However, they shall submit duly signed WBKVIB Tender document for having accepted the terms and conditions of this tender to participate in the proposed e-auctions.

NCDEX e Markets Ltd officials will scrutinize the application forms received and relevant documents submitted. The applicants will be informed regarding acceptance / rejection of their applications.

The details of Warehouse/Godown/Plant wise quantity will be uploaded on [www.market.neml.in](http://www.market.neml.in) regularly as and when the e-auction(s) is scheduled to be held.

### **3. PROCESS OF ELECTRONIC BIDDING SYSTEM**

The NCDEX e markets Ltd after scrutiny of application for registration will enroll the applicants on the e-auction platform subject to certain eligibility criteria as prescribed by the NCDEX e markets Ltd in consultation with the West Bengal Khadi and Village Industries Board For the purpose of the e-auction(s), Registered Participant will be allotted with user ID and password by NCDEX e Markets Ltd. The Registered Participant with such Registered Participant ID and password are only eligible to participate in the e-auction(s).The NCDEX e Markets Ltd in consultation with the West Bengal Khadi and Village Industries Board shall schedule the e-auctions of Khadi material and/or products such details viz., auction calendar will be published on NCDEX e markets Ltd website i.e. [www.neml.in](http://www.neml.in). The Registered Participant will not be intimated individually regarding the e-auctions. However, the registered buyers may contact NeML relationship manager. Alternatively, the Registered Participant may contact the Customer Service Group of NCDEX e Markets Ltd on phone numbers (+91-22) -48810500 for information on schedule of e-auction(s). The Registered Participant shall take adequate care and are solely responsible to obtain details of the schedule of e-auction(s) through the website [www.neml.in](http://www.neml.in) in their own interest.

Every registered Participant will be provided with unique virtual account number by NeML. The registered Participant shall deposit 2%(Percent) of the bid value as EMD

(margin money) with the NCDEX e Markets Ltd in to the provided Virtual Account to participate in the proposed auctions by way of RTGS or electronic fund transfer, well in advance i.e. at least one day before the scheduled date of proposed e- auction in which the registered Participant propose to participate. Participants are required to deposit additional 1% of the bid price into their virtual account. The Transaction charges @1%+18%GST=1.18% shall be deducted from additional 1% deposit of only the successful bidder.

The Registered Participant shall be allowed to bid only if the requisite EMD is available in the EMD Account (as mentioned in Clause 4.6) of NCDEX e Markets Ltd. The amount deposited as EMD would determine the bidding capacity of the bidder. Since the 2% EMD calculation is dynamic based on H1 incremental Bid Price \* Qty, therefore bidders are requested to keep sufficient EMD amount into their virtual account.

In case, if any bid is received 3 minutes prior to the scheduled e-auction closing time then the e- auction(s) schedule shall be extended for 5 minutes over and above the scheduled closing time of e- auction (s). There shall be 3 extensions. During standard auction time and during the extensions if no bid received in last three minutes, then auction will be closed automatically.

The bidders shall place their bids online on NeML Platform <https://market.neml.in>, the online trading system made available by NCDEX e Markets Ltd as per the terms and conditions of the tender. Price to be quoted lot wise on net weight basis, as per the details specified for a particular delivery location as available on the website of NCDEX e Markets Ltd. The lots are offered for sale on "as is where is basis and as is what is basis." The evaluation and finalization of bids received shall be made based on the highest price quoted by the bidders in respect of each lot.

Further there shall be no role of NeML in the qualitative and/or quantitative aspects of the stocks / commodities auctioned. Should there be any dispute regarding the qualitative and/or quantitative aspects of the stocks / commodities the same shall be resolved between buyer and seller inter se. NeML shall not be responsible with respect to these disputes and shall not be made party in any of such dispute/litigation etc.

The Price quoted shall be on net weight basis per Kg (for Yarn) and per Pcs (for Than) on (Ex-warehouse/Ex-works) on "as is where is basis" for each lot and are:

- a) Exclusive of all incidental expenditures at the Warehouse/Godowns/Plants (if any) & Applicable Entry tax/ GST. The quotation basis shall be exclusive of tax and levies as may be applicable. The buyer has to bear all such expenses as per the actuals.
- b) The delivery shall be on an ex-warehouse/ex-plant basis. All cost including labour charges, scrap lifting and cutting equipment hiring charges, material handling cost, all type of logistics cost, loading, unloading to truck from warehouse, transportation, Hamali charges, weigh bridge charges, all taxes, fee, levies plus GST as maybe applicable will be borne by buyer separately as per actual.
- c) Exclusive of Transaction Charges payable to NCDEX e Markets Ltd. The Transaction Charges at the rate of 1% of Traded Value and applicable GST @18% on the Transaction Charges shall be payable by the Buyer. The Bids of all Bidders who have

participated in the e-auction(s) will remain valid for a minimum period of five working days from the date of e-auction(s). The Bidders are required to quote in Indian Rupees per Kg (for Yarn) and per Pcs (for Than) or each e-auction. The West Bengal Khadi and Village industries Board may specify, if desired a floor price below which no bids may be accepted by NeML Platform. The minimum tick size shall be Re. 0.01(One Paisa) and maximum tick size shall be Rs 100 (ten thousand paise). During the bidding session, a bidder may modify his bid up wards to an increased value higher than the existing highest bid. No cancellation of Bids shall be allowed during the e-auction session. The WBKVIB & NCDEX e Markets Ltd shall not be responsible for any failure of power, network, server, bandwidth problems, hosting server, internet connectivity, ISP or otherwise or the slowness to access NCDEX e Markets Platform <https://market.neml.in>. In case the e-auction is not concluded/completed as scheduled for any reason whatsoever including technical reasons, NeML may, in consultation with The WBKVIB reschedule the e-auctions on the same or different date on same or modified terms and conditions, details of which shall be published on NeML website.

#### **4. POST AUCTION PROCESS:**

Since the rates of items are different and the quantum of stocks are not same in respective stock points, intended bidders may place their values for single and multiple items. In all the cases WBKVIB will possess the right to opt for the higher values. In case of placement of bids for multiple items by one bidder, if the instance seems advantageous for WBKVIB in respect of disposal of the old stock at a higher value WBKVIB will have the authority to accept the offer. The decision on whether or not to accept a the highest bid shall be at the sole and absolute discretion of WBKVIB and no claims or disputes shall be entertained by the bidders in this regard.

EMD of the all bidder(s) in e-auctions would be blocked by NCDEX e Markets Ltd. Post approval of bids by WBKVIB ,EMD of the unsuccessful Bidder(s), including those whose bid(s), which are not accepted due to non-fulfillment of the conditions of the tender document, shall be refunded to the bidder on the withdrawal request made by Registered Participant through <https://market.neml.in/> latest by one working day from the day of close of e- auction(s).

The bid of each lot as declared by the WBKVIB is binding on all bidders. Any requests for cancellation of bids received either during the auction session or after the conclusion of an e- auction(s) session shall not be accepted. Failure to accept award of Sale by the successful bidder shall result in the forfeiture of the EMD. Any bid placed using the bidder's user ID and the password shall be deemed to be an unconditional binding of the bidder to whom such user name and the password has been allotted by NCDEX e Markets Ltd, inter-alia, for the purpose of the e-auction(s) and the bidder shall be solely and fully responsible for all the activities that occur under such user name and password. The user is therefore advised to check the username and the password before the e- auction(s) and is advised not to reveal it to anyone else to prevent misuse of the same. The WBKVIB shall evaluate all the bid after conclusion of auction and has the right to accept or reject the bid if found not competitive. Authorized person from Seller shall inform to NeML via registered email id on the auction result. Back-to-Back confirmation of acceptance or rejection of highest bid will be intimated by NCDEX e Markets Ltd by email to the registered e-mail ID of the registered buyer.

Total 2% of the approved auction value amount will remain blocked into bidder virtual account till final lifting of the stock.

The Invitation of Bids, the terms and conditions of the WBKVIB tender, Bid of the Successful bidder, Letter/Email Confirmation/Acceptance issued by the WBKVIB to the successful bidder (Buyer) along with any amendment issued prior to award of e-auction(s) shall constitute the terms and conditions of valid and binding contract between the Seller and the Buyer enforceable in the court of law

The EMD will remain blocked till full and final delivery of material against delivery order. The same will be in accordance with the terms and conditions of WBKVIB tender document and completion of the clearing and settlement process by NeML.

In case of unsuccessful bid of the bidder, the EMD will be refunded by NCDEX e markets on the next working day. If the bidder wishes to retain the EMD, the same would be retained by NCDEX e Markets Ltd for participation in the subsequent e- auctions.

The successful bidders will be charged transaction charges of 1% (one percent) of the Traded value and applicable GST by NCDEX e Markets Ltd.

TDS u/s194-O (current rate @ 0.1 %) of Income Tax Act,1961and GST-TCS u/s 52(current rate @0.50%) of CGST Act, 2017 will be deducted from seller payout on final trade value. Both TDS and GST-TCS are applicable to seller.

NCDEX e Markets Limited is only acting as a e-auction service provider for the purpose of the e- auctions and shall not take any responsibility whatsoever relating to profit or loss suffered by any Buyer or Seller on account of Registered Participant's participation in e-auction process. NeML shall not be held responsible or liable by Buyer and Seller in this regard.

## **5. FUND AND DELIVERY PROCESS.**

The successful bidder/buyer will get 30 days for the partial payment and lifting of the stock calculated from the date of approval.

The successful bidder will have two options:

**(A)** The Bidder may deposit total trade obligation value into their virtual account and generate the partial Delivery order

Or

**(B)** One time delivery order valid till 15 days from the date of approval.

In case if buyer wish to lift the stock in staggered manner, then he has option to make part payment and accordingly generate the equivalent quantity Delivery Order. The successful bidder will generate the on-line delivery order after making payment partial or full calculated on the approved price. In case of in-sufficient funds, on-line delivery order will not be generated. Validation of on-line DO and final issuance of the delivery order by

WBKVIB subject to conditions:

After delivery order generation, NeML shall transfer the payment after deduction of TDS and TCS-GST to WBKVIB bank account in one bank working day from the date of delivery of order generation. NeML shall send the payout report to the Seller authorized staff registered email id.

NeML send the Delivery order copy via email to the Seller authorized person email id with a copy to buyer email id.

The final delivery order will be issued by WBKVIB only to the extent of amount received from NeML. Partial payment and delivery are allowed. NeML CSG team will send the auction confirmation email to the approved bidders after receipt of the approval.

Since the awarded rate will be fixed for the 30 calendar days from the date of confirmation, successful buyer/buyers must lift the entire material available and generated during the period.

Upon issuance of delivery orders, the awarded quantity of stocks shall be lifted within the stipulated period, as specified by the WBKVIB, given for each lot from the date of intimation of acceptance of the bid. Failure to take delivery within the stipulated time as specified by WBKVIB will attract forfeiture of Buyer's EMD. Upon receipt of email from the Seller about buyers' default, NeML shall transfer the EMD amount to the Seller's designated Bank account.

Violation of any of the Clause/Clauses of this Tender document shall be deemed as violation of Terms and Conditions of WBKVIB Tender.

Non-acceptance of award of WBKVIB Tender within two working days of declaration of e-auction results will amount to forfeiture of EMD deposited. The buyer, through his authorized representative, while taking delivery of traded stocks shall submit delivery order issued by WBKVIB to the warehouse/plant officials who will facilitate the delivery of stocks from the Warehouse/Plant. The Buyer or his representative is required to furnish photo identity proof to the warehouse/Plant authorities. The Warehouse/Plant authorities shall deliver the quantity of stocks as mentioned in the delivery order in front of authorized representatives of Warehouse/Plant, WBKVIB and the Buyer. WBKVIB will provide sale certificate plus applicable GST, if any to the concerned authorities on behalf of the buyer before giving delivery of stocks.

**Default Scenario and settlement process:**

Giving proper delivery of the Stock is the sole and exclusive responsibility of the Seller. In case the Seller is unable/fails to give delivery of the traded stocks or the delivery is delayed beyond reasonable period, for any reasons whatsoever, including any third-party claims and/or disputes and/or change in commodity traded for, the trade shall be treated as cancelled by NeML and EMD and/or sale proceeds or any other amount deposited by the Buyer shall be returned without any interest by NeML.

Delay or refusal in taking delivery of traded stocks by the Buyer beyond the permissible time limit, shall result in forfeiture of the EMD and the same shall be transferred to WBKVIB after deducting Buyer Transaction Charge of 1%plus GST. Successful buyer

after collecting the delivery order issued from WBKVIB, shall intimate WBKVIB the date of taking delivery of traded stocks from warehouse within the allocated delivery timelines to enable WBKVIB to make necessary arrangements for delivery of stocks. Upon successful completion of the delivery process, EMD will be unblocked and shall be returned to the buyers for further utilization in the auction or buyers may put withdrawal request.

TDS u/s 194-O (currently @ 0.1%) of Income Tax Act,1961 and GST-TCS u/s 52 (currently @ 0.50%) of CGST Act, 2017 and Transaction charges @1% plus GST (applicable @18%) will be deducted after full lifting of materials on final Trade value. Both TDS and GST-TCS are applicable to seller. The amount deducted by NeML as tax will be deposited as per the rules of Income tax or GST, within the prescribed time limits. The deduction of tax shall be subject to change in the laws applicable from time to time

The department has issued a clarification (vide circular\_13\_2021 dt. 30-06- 2021) regarding non-applicability of TDS u/s 194Q, if the transaction is subject to TDS u/s 194-O i.e. transaction on which TDS deducted by NeML than on such transactions buyer will not apply TDS u/s194Q.

## **6. RESOLUTION OF DISPUTES**

In case of any disputes relating to sale including the interpretation of any of the Clause/Clauses of the WBKVIB tender, the dispute shall be referred to the authorized person of the WBKVIB. The decision of authorized person of WBKVIB shall be final.

In case the matter remains unresolved or the aggrieved party is dissatisfied by the decision taken by the authorized person of WBKVIB, the dispute shall be referred to a sole Arbitrator mutually appointed by the parties and the Arbitration Proceedings shall be conducted as per the Arbitration and Conciliation Act 1956 along with its amendments from time to time. The decision of the Arbitrator shall be final and binding on the Parties to the dispute. The language of Arbitration shall be English and seat of Arbitration shall be at Kolkata, West Bengal.

NCDEX e Markets Limited is acting only as a service provider for this e- auction, as per this document and with the express instructions received from the Seller in this regard. NeML shall not be a party to the contract between the Seller and the Buyer after successful completion of e- auctions. By bidding in this e-auction, a bidder acknowledges that NCDEX e Markets Limited shall not be held responsible for any loss that he/she/they may suffer because of this e-auction or non-adherence of these terms and conditions.

NCDEX e Markets Ltd will be providing e-Auction platform for the purpose of conducting the e-auction only and shall not take any responsibility whatsoever in connection with any disputes that may arise during the tenure of the tender/contract or thereafter. Both seller and buyer shall completely absolve NCDEX e Markets Ltd of any consequences resulting out of this tender and further any disputes between.

Buyer and seller shall have to be resolved by them as per above clause. Both Buyer and Seller agree and acknowledge that NeML shall not be made party to any litigation, suit, petition, application, arbitration or appeal arising from the dispute between buyer and seller except in case of NeML gross negligence and willful default. . In case the buyer/seller makes NeML a party to the litigation, then all costs with respect to the litigation shall be borne by the Petitioner without

delay or demur.

Both the buyer and the seller agree and accept to indemnify and keep NeML indemnified from all the claims, losses or expenses that NeML may incur/suffer because of inclusion of NeML as a party to any dispute between buyer and seller. Court situated in Kolkata, West Bengal. shall have the jurisdiction in the matter.

## 7. FORCEMAJEURE

Should any of the force majeure circumstances, namely act of God, natural calamity, fire, Government of India Policy, restrictions( excluding any stock limits), strikes or lock-outs by workmen, war, military operations of any natural and blockades preventing the Seller/Buyer from wholly or partially carrying out their contractual obligations, the period stipulated for the performance of the Contract shall be extended for as long as these circumstances prevail, provided that, in the event of these circumstances continuing for more than two months, either party shall have the right to refuse to fulfill its contractual obligations without title to indemnification of any losses it may thereby sustain. The party unable to carry out its contractual obligations shall immediately advise the other party of the commencement and the termination of the circumstances preventing the performance of the contract. A certificate issued by the respective Chamber of Commerce shall be sufficient proof of the existence and duration of such circumstances.

I/We have read the Terms and Conditions of e-Auction for the sale of scrap metals and unconditionally and unequivocally agree to abide by terms & conditions stipulated above. The duly signed terms and conditions of
