May kindly refer the circular of even no. dated 06.01.2014 issued from the desk of Chief Executive Officer, KVIC directing therein to communicate the Khadi Mark Regulations, 2013 to all concerned in your jurisdiction.


2. As you are aware that Khadi Reform and Development Programme (KRDP) is an ambitious programme initiated by Govt. of India with assistance of ADB. The progress of various activities under KRDP is being reviewed through series of meetings with Ministry of MoMSME, DEA and ADB. One of the major 2nd Tranche conditions in KRDP policy matrix is registration of KIs for Khadi Mark as per Khadi Mark Regulations, 2013.

3. In the aforesaid Circular, **Form I** and **Form II** are enclosed for registration of Certified Khadi Institutions and Persons respectively. The said circular has also been uploaded on KVIC's website (www.kvic.org.in) under Circulars-RID.

4. All State and Divisional Directors are advised to ensure immediate distribution of Form I among all khadi institutions working under the jurisdiction of their office. This work should be completed positively by 10th February, 2014. Further all State and Divisional Directors are advised to collect filled in Form I from Khadi Institutions by 20th Feb, 2014 and arrange to forward those Forms after scrutiny to Director CCC for placing them before the Central Khadi Mark Committee (CKMC).

5. While forwarding the scrutinized applications to Director CCC, a consolidated position/list may be furnished to Directorate of RID, KC and Zonal Dy.CEO for information and records.
