West Bengal Khadi & Village Industries Board intends to invite applications from bonafied agencies for Distributorship/Dealership of tube-packed Nalen Gur on behalf of West Bengal Khadi & Village Industries Board.

Pre-Qualification criteria:-

- a) The Applicant should be a Trader of Jaggery/Nalen Gur/FMCG and related products wherever applicable.
- b) The Applicant shall have experience of selling/supplying Jaggery/Nalen Gur/FMCG related Products during the last three financial years in their own name or through PSUs, State/Govt. Agencies.
- c) The intending firm/ Organisation should have experience in selling FMCG products for at least for three years
- d) The intending firms /organisations should have Valid GST Registration and valid PAN.
- e) The applicant should be profit making for last three years FY with positive net worth.

Documents to be Submitted

- a) The applicant should submit documents in support of their credentials for selling/supplying Jaggery/Nalen Gur/FMCG Products such as copies of purchase orders and copies of performance certificates.
- b) Self-attested copy of Income Tax Return for the Assessment Years 2020-2021 or 2019-20 along with self-attested copy of PAN Card of the Agency/ organisation etc.
- c) GST registration Certificate failing which application shall be held liable for cancellation.
- d) Trade licence for the similar work.
- e) Affidavit for not being blacklisted by any Government/ Private institution in Non-judicial stamp paper.
- f) Audited Balance Sheet and Profit & Loss Statement of the Company for the last 3 financial years i.e. 2013-14, 2014-15 and 2015-16.
- g) Signature of Partners/Directors/Proprietors duly attested by the bank.

h) Registration under Partnership Act (Partnership deed for Partnership Firm only) along with Power of Attorney to be submitted with the bid.

Terms & Conditions:

- a) MOU to be signed with WBKVIB.
- b) The Financial Terms and Conditions should be maintained as per MOU.
- c) Any changes or alteration in Terms and Conditions credit note, discounts, payment terms etc. will be finalised during the signing of MOU.
